Suspension due to outstanding payment

We took a break during autumn vacation in week 42 but have resumed processing the suspension backlog and have worked through approx. 60%.

We expect to maintain a constant rate in the coming weeks. With this rate, we will catch up and have everything processed by mid-November.

Prepaid balance notifications

We are finalizing the development of prepaid balance notification: Enable registrar alerts on prepaid balance [known issue #1956].

With the new registrar alerts, you will be able to place fixed alarms in your registrar managed account, so you get noticed when your account has low balance. The alerts will be sent to the email address you have chosen in the registrar account for you to have the chance to top up your account in time.

When this feature has been implemented it will no longer be possible to register new domains if there is no credit in your prepaid registrar account - so make sure to have credit on your account.

We will make sure to keep you updated on this new feature so stay tuned for more information coming up very soon...

Planned release

The following updates are currently planned for production release on November 7th, 2022.

EPP-4.6.0

- Possible to transfer domain name to yourself (known issue #1954)
- Missing receipt to former NSA on completed domain redelegation (known issue #2038)
- Allow NSA to modify DNSSEC on registrar handled domains (known issue #2043)
- domain:paDate incorrectly formatted (known issue #2066)
- host:create triggers request to linked NSA on non .dk nameservers (known issue #2071)

SB-5.11.0

- Support input and validation of EAN number during client creation
- Fix domain name missing from ID control email reminder (known issue #2085)
- Various minor layout and bug fixes

WHOISD-5.1.0

- Add display of registrar on registrar handled domains not yet activated (feature request #2096)
- Remove display of registrant information on domains where registrant ID not yet confirmed

Operational status notifications

It is possible to subscribe to information about spontaneous incidents (incidents) and scheduled maintenance.

Planned releases are announced via our status portal as well. New features will be announced no less than 3 weeks prior to release, whereas system changes with no backwards compatibility will be announced no less than 3 months prior to release. Bug fix releases can be released on a day-to-day basis based on severity.

On status.dk-hostmaster you get an overview and can subscribe to get notifications on DK Hostmaster's services and operational status.
