New feature releases

Update on payment and invoices for registrants on registrar managementOur selfservice platform has been updated with new icons as it was unclear for registrants on registrar management, who has the payer role. All registrants on registrar management can now see that the invoicing takes place through their registrar.

Clarification of icons in self-service when domains are registrar managed Update of icons in selfservice platform for a better overview of the different roles and services.

Status on tjekpånettet.dk

Since its launch back in August, <u>tjekpånettet.dk</u> has been used more than 80.000 times to test a link, and hopefully it has saved some from getting scammed. This is way past our expectations.

This past Saturday, the second leg of the promotion campaign went live, with a tv-spot on TV2 Play in the weeks up to Black Friday. Beginning 15. November we will support this on social media and with Google.

Please feel free to help us promote the initiative, so we can work on a safer internet for all.

NemID has now been replaced with MitID

From 31 October 2023 NemID was closed down, and it is therefore no longer possible to log in to our self-service using NemID.

Your Danish customers must therefore use their company/ private MitID (depending on their user type), to perform the required id-check.

Existing Danish users will be asked to add MitID instead of NemID, when they log in to the self-service at punktum.dk with their current user ID and password.

Feature requests and known Issues

All feature requests and known issues we are currently evaluating, planning, currently working on, their progress and the ones we have fixed can be found here.

Operational status

On <u>status.punktum.dk</u> you can get an overview of Punktum dk's operational status and services.

Planned releases are announced via our operational status as well.

New features will be announced no less than 3 weeks prior to release, whereas system changes with no backwards compatibility will be announced no less than 3 months prior to release.

Bug fix releases and security updates can be released on a day-to-day basis, based on severity.
