Incentive payout for July to December 2023

The incentives for the period from July to December 2023 have been paid out. If you have an incentive agreement with us, you have received a separate e-mail including information about your incentives.

Postponed id-check of registrants

We have approximately 1100 registrants, where the requirement for id-check was postponed due to issues with MitID in our system.

All issues have now been fixed, and we will soon start sending e-mails to the 1100 registrants, with a requirement to complete the id-check within 30 days. We will send out the e-mails in small portions over a few weeks.

Feature Request #2149: Change DNSSEC display in WHOIS

As Punktum dk no longer supports registrant deactivation of DNSSEC on their domains via our self-service portal, the requirement to display granular status text is no longer relevant.

All of the following status text will be replaced with "Unsigned delegation":

- Unsigned delegation, DNSSEC disabled, no records
- Unsigned delegation, DNSSEC disabled, keys unpublished
- Unsigned delegation, DNSSEC disabled
- Unsigned delegation, no records
- Unsigned delegation, DNSSEC enabled, keys unpublished
- This change will be deployed into production on Wednesday, February 7th, 2024
