We are looking forward to the two upcoming registrar meetings on 21. March and 3. April (invitation was sent two weeks ago) and hope to see as many of you as possible.

For now, we will give you a brief update on news and improvements from us.

### Update to our manual ID check

We have changed our manual ID check process to increase flexibility, resulting in a decrease in the number of rejected documentation cases.

We conduct a comprehensive evaluation of all submitted documentation. If the documentation falls short of meeting our requirements by a small margin, we evaluate the entirety of the submitted documents and may still approve them.

### Enhanced validation: VAT numbers during contact creation

To enhance the overall quality of contact data, we are introducing VAT number validation during contact creation via EPP for Danish businesses utilizing the Central Business Registry (CVR). In cases where invalid VAT information is provided, the contact creation process will be declined. We anticipate that this additional feature will be implemented early in Q2 2024 as part of the EPP-4.11.0 release.

Furthermore, with this release, we will incorporate a new extension that provides information on the VID (registry lock) status for domains. The new extension, dkhm:VID, will be integrated into our dkhm-4.4 schema. (see <u>https://github.com/Punktum-dk/epp-xsd-files</u>).

Please be aware that previous iterations of the dkhm-4.4 schema included a new extension for providing information on contact ID check status. However, as part of our ongoing efforts to ensure compliance with NIS2 regulations, this extension requires redesigning and will consequently be added in a later version of the dkhm-4.5 schema.

Additionally, in the forthcoming EPP release, we will continue to support both dkhm-4.3 and dkhm-4.4 schema versions in our production environment for an extended period. This allows registrars the flexibility to transition to the new version at their own pace when they are ready.

#### Utilization of secondary contact email

In the event of email bounces, our system will now initiate automatic retries by sending the failed email to the contact's secondary email address, if provided. Alongside the original message, details regarding the unsuccessful delivery will be included.

Furthermore, if the contact logs into the Punktum dk self-service portal following the bounce, they will automatically be prompted to review and update their contact information.

# Pre-registrar meeting survey

In the brief survey recently sent out, you have the chance to share your thoughts on the products and services currently under development.

The subjects covered will be further explored during the registrar meetings at Punktum dk on March 21, as well as in the online session on April 3.

### Typo-squatting alternatives on Unikpånettet.dk

In response to registrar input, we're developing alternative domain names using popular open-source typo-squatting tool. This will complement our existing dictionary-based suggestions, expanding the range of options available to users.

### New user guides and FAQs available

We have released additional user guides and FAQs on our website. These resources have been created in response to registrar feedback, aiming to enhance support for your .dk domain name management tasks. Covering a wide range of topics including registrar portal functionalities, technical settings, and domain name handling, these guides and FAQs provide comprehensive insights and assistance.

#### Feature Request #2149: Change DNSSEC display in WHOIS

As Punktum dk no longer supports registrant deactivation of DNSSEC on domains via our self-service portal, the requirement to display granular status text is no longer relevant. This change was deployed into production on Wednesday, February 7th, 2024
