### **OPT-IN, COURSES AND MEETINGS**

### Opt-in help to Registrar Management

Some of you have expressed a desire for assistance with registrant opt-in for registrar management. We've been collaborating with some of you on this, and the initial emails will be sent out soon as a pilot project. We'll keep you informed about whether this approach helps with opt-in to registrar management.

In October, Punktum dk held a course for one.com's support staff. The course provided among other things insight into the Danish model for managing .dk domain names and how the Domain Act and the internet community influence our work.

### **VARIOUS UPDATES**

### NIS2 Test Update

The NIS2 law proposal was supposed to take effect from March 1, 2025. However, the law process is delayed. This means that the NIS2 law will likely not come into effect until the summer of 2025. This means that the planned test of the updated systems due to NIS2 will be postponed as well.

## Update of Terms and New Price Increase Model

As of January 1, 2025, Punktum dk's term and conditions will be updated. The update contains three important changes:

- New Price Increase Model. From 2025 the price for a .dk domain name will be regulated after the Danish Net Price Index published by Statistics Denmark. Every year April 1 the price can be increased according to the Net Price Index.
- Fee for transfer of domain names is waived . It will be free of cost from January 1, 2025, to transfer a domain from one registrant to another.
- Data and ID check can be performed by a registrar. As the NIS2 directive will be implemented in Danish law in 2025, we will add the possibility for a registrar to perform data and ID check of registrants.

Information about the update of our terms and what it contains will be sent out to all registrants during November.

## Phishing Attack against .dk-domain Registrants

We are unfortunately still under a phishing attack against .dk-domain registrants. The attackers use multiple sender email addresses to carry out the attack.

### New Registrar Portal: Production Phase and Testing

Thank you to those of you participating in our registrar survey sessions and for providing valuable input on the new Registrar Portal.

The first phase of the project, "Analysis and Concept," is set to be completed by the end of October 2024. After this, we will transition to the Production phase.

In this phase, we will gradually invite all registrars to participate in testing. If you are interested in taking part, please reply to this email, and we will provide more details on the next steps. We hope you will join!

## Unikpånettet.dk, sikkerpånettet.dk, tjekpånettet.dk

As most of you know, we launched unikpånettet.dk in the middle of August 2024. Since then, close to 5000 have used the site, 131 domain names have been referred to registrars and 10 domain names have been registered.

Tjekpånettet.dk is now about a year old and has been used over 1.000.000 times. On October 24, 2024, we launched a browser add-on with a small campaign on Facebook.

Sikkerpånettet.dk is still going strong, and here we have solid traffic and use. As of October, more than 250.000 have tested a domain, and more than 70.000 have tested an email server.

### Update - New Features in the Registrant Self-Service Portal

Thursday, October 10, we released enhanced login capabilities to the self-Service Portal including:

- The option of receiving one-time passwords using mobile text messaging (SMS)
- Ability to disable login via username/password if eID-solution (MitID) is associated with user account.
- Selection of preferred payment method during payer role acceptance flow.
- Various minor layout and error corrections.
